# **DISTINGUISHING FEATURES OF THE CLASS:**

This work involves responsibility for the safe and efficient operation of various types

of light motor equipment and the performance of manual duties related to the operation of the equipment. The work also involves the performance of a variety of unskilled labor tasks. This class is distinguished from that of Heavy Equipment Operator in that the work primarily involves the operation of motor equipment that is not classified as heavy equipment. This class may however, operate heavy equipment on a relief or trainee basis. The work is performed under general supervision with some leeway allowed for the exercise of independent judgment. Supervision may be exercised over the work of Laborers or others on specific tasks. Does related work as required.

## **TYPICAL WORK ACTIVITIES:** (Illustrative only)

Operates a truck in connection with the hauling of material for road construction and repair, removal of snow, and refuse; Operates a truck to transport workmen, tools and other equipment;

Operates a tractor mower in connection with mowing grass and/or removing brush from roadsides or other locations as needed; May perform preventative maintenance on assigned equipment;

Performs a variety of manual tasks such as loading and unloading vehicles, digging ditches, cutting trees and brush, cleaning culverts, shoveling snow, painting, raking blacktop, and road and sewer maintenance work;

May, on specific assignment, occasionally operate heavy motor equipment that includes but is not limited to power shovels, bulldozers, graders, rollers, cranes, loaders and sweepers.

Performs other duties as assigned.

## FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES, AND PERSONAL CHARACTERISTICS:

Good knowledge of the operation of trucks, tractors, snow removal equipment, and other types of related motor equipment and related attachments;
